  - (a) If the status of your company/organization is " $\underline{Sole\ Proprietorship}$ " or " $\underline{Partnership}$ ", the required supporting documents are :
    - A copy of the valid Business Registration Certificate; AND
    - A current <u>Certified Copy of an Extract of Information on the Business Registration Register</u> issued by the Business Registration Office, Hong Kong. (Form 1(a) or Form 1(c) as appropriate)
  - (b) If the status of your company/organization is a "Limited Company", the required supporting documents are:
    - A copy of the valid Business Registration Certificate; AND
    - A copy of Certificate of Incorporation in respect of the corporation.
  - (c) If the Status of your company/organization is not one of the above, the required supporting documents are:
    - A copy of the valid Business Registration Certificate; **OR**
    - A copy of the documentary proof that your organization is legally registered in Hong Kong; AND
    - Proof of company address. (e.g. Copy of electric bill; Telephone bill etc.)

- If the radio system to be used has no prior frequency assignment from the Office of the Telecommunications Authority, the processing of the application may be delayed.
- 5. The application form must be signed by the proprietor of the company/firm if the application is from a company/firm of "Sole proprietorship". If from a "partnership" company, the application form must be signed by one partner signing "For self and Partners". A director or manager should sign for a company incorporated under the Companies Ordinance or other body corporate. Please sign and return the application form together with the relevant supporting documents as mentioned in NOTE 1 above to the Office of the Telecommunications Authority, Licensing Unit, 26/F., Wu Chung House, 213 Queen's Road East, Wan Chai, Hong Kong. If your application is approved, we will notify you in writing for the payment of the necessary licence fee. The annual licence fee is HK\$80 per system.
